Article VI Section 1

Article VII Section 1

Article VII Section 2

Article VII Section 3 (New)

Add "Wherever these Bylaws or subsequent amendments may be found to be in conflict with the present or any future Department or National Bylaws, the latter shall prevail and be binding on this District as though written herein."

Reason: To conform to Section 402 of the National Bylaws.

ARTICLE III GOVERNING BODY

Section 1:

GOVERNING BODY: The District Convention will be governed by the District Commander, subordinate to the Department and National Conventions.

Section 2:

The District Convention and Meetings shall consist of

- a. The Commander-in-Chief and Past Commanders-in-Chief who are members in good standing in a Post in the District.
- b. The National Council of Administration member who is in good standing in a Post in the District.
- c. The Department Commander and Past Department Commanders who are members in good standing in a Post in the District.
- d. The District Commander, all Past District Commanders who are members in good standing in a Post in the District, all elected officers of the District and the Adjutant.
- e. All Past Commanders throughout the District. In the absence of the Past Commander, the Past Senior Vice Commander, or, in their absence, the Past Junior Vice Commander may function as a member of the Convention or meetings.
- f. Delegates to be elected by the Posts in the District.

**BYLAWS
DISTRICT 10
DEPARTMENT OF ARIZONA
VETERANS OF FOREIGN WARS**

**ARTICLE I
NAME AND JURISDICTION**

Section 1:

NAME: This subdivision of the Department of Arizona, Veterans of Foreign Wars of the United States shall be known as District Ten (10), hereafter referred to as "District".

Section 2:

JURISDICTION: The jurisdiction of the District shall consist of those Posts assigned by the Department of Arizona as listed in the Department Bylaws.

**ARTICLE II
OBJECTS**

Section 1:

OBJECTS: The objects of the District shall be as set forth in the *Congressional Charter* and National Bylaws, together with the Bylaws of the Department of Arizona and to offer all possible aid and assistance to every Post in the District.

**ARTICLE III
GOVERNING BODY**

Section 1:

GOVERNING BODY: The District Convention will be governed by the District Commander, subordinate to the Department and National Conventions.

Section 2:

The District Convention and Meetings shall consist of:

- a. The Commander-in-Chief and Past Commanders-in-Chief who are members in good standing in a Post in the District.
- b. The National Council of Administration member who is in good standing in a Post in the District.
- c. The Department Commander and Past Department Commanders who are members in good standing in a Post in the District.
- d. The District Commander, all Past District Commanders who are members in good standing in a Post in the District, all elected officers of the District and the Adjutant.
- e. All Post Commanders throughout the District. In the absence of the Post Commander, the Post Senior Vice Commander, or, in their absence the Post Junior Vice Commander may function as a member of the Convention or meetings.
- f. Delegates to be elected by the Posts in the District.

ARTICLE IV CONVENTIONS

Section 1:

CONVENTIONS: The annual District Convention for the election of officers and transaction of business shall be held not less than ten (10) days nor more than *seventy-five (75)* days prior to the convening of the Department Convention.

Section 2:

MEETINGS: Regular meetings shall be held on a Sunday in the months of July, October and January for the transaction of business and any other matter pertaining to the District or Veterans of Foreign Wars that may come before the body. The time and place of the District Convention will be set at the January Meeting.

Section 3:

QUORUM: The minimum number of delegates required to constitute a quorum for the transaction of business at a District Meeting or Convention shall not be less than one (1) member each from *fifty (50) percent* of the Posts in the District. For the purpose of this section the Post Commander shall be considered a delegate.

Section 4:

DISTRICT DUES: The annual District dues shall be **seventy-five (75) cents** per Post member annually based on the transmittal of April the thirtieth (30th). Dues are payable **NLT the first District Meeting of the new year.**

Section 5:

A registration fee shall be assessed each member attending a District Meeting or Convention. Such amount of fee to be established by a two-third (2/3) vote at a District Meeting.

Section 6:

SOLICITATION OF FUNDS: Solicitation of funds will be provided as to Section 414 of the Manual of Procedure. No Post will solicit funds at any District Convention, meeting or special meeting excluding host Posts normal functions, without the approval of the District Commander.

Section 7:

ELIGIBILITY TO OFFICE: Any member in good standing in a Post in the District shall be eligible to any office in the District; provided that no member shall hold two (2) elected District offices at the same time, but may hold one (1) elected and one (1) or more appointed offices. District officers, elected or appointed shall be eligible to hold office in a higher or lower body. Such offices may be held concurrently.

Section 8:

DISTRICT OFFICERS:

- a. The elected officers of each District shall be Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Judge Advocate, Surgeon, Chaplain and three (3) Trustees.
- b. The Commander shall appoint the Adjutant, Service Officer, *Inspector*, Officer of the Day, Guard and other such officers as deemed necessary for the pleasure of the District Commander. The Trustees shall audit the books and records of the Quartermaster and Adjutant at each regularly scheduled meeting and report of such audits shall be furnished to the Department as required of the District.

- c. District officers, elected or appointed shall submit proof of eligibility for the files of the Adjutant prior to their installation following their election or appointment. Such proof of eligibility records shall be open to the District Commander, District Adjutant and District Quartermaster. District officers, elected or appointed shall not be installed or assume the duties of their office until such proof of eligibility is in the files of the District Adjutant.

Section 9:

Nomination, election, installation and term of office shall conform to Section 417 of the National Bylaws.

Section 10:

DUTIES OF OFFICERS: Duties of officers shall conform to Section 418 of the National Bylaws and such duties as assigned by the District Commander.

Section 11:

DELEGATES: Delegates to the District Convention shall be elected at a regular meeting of the Post held *in April*; one (1) delegate and one (1) alternate for each *thirty (30)* members or fraction thereof in good standing in the Post of the current year.

ARTICLE V COMMITTEES

Section 1:

COMMITTEES: All Committee shall be appointed by the District Commander within fifteen (15) days following the annual District Convention for the election of officers. The standing committees shall be (1) Service and Welfare; (2) Employment; (3) Legislative; (4) Youth Activities; (5) Resolutions; (6) Publicity; (7) Buddy Poppy; (8) Voice of Democracy; (9) Loyalty Day; (10) Safety; (11) Community Service; and (12) Membership.

ARTICLE VI RESOLUTIONS

Section 1:

RESOLUTIONS: All resolutions to be submitted to the Department must be in accordance with Article VI of the Department Bylaws.

Section 2:

SUBMISSIONS: All resolutions submitted by the Posts to the District must be typewritten, printed, or mimeographed in triplicate and must be in the hands of the District Resolutions Committee not less than sixty (60) days prior to the Department Convention.

ARTICLE VII MISCELLANEOUS

Section 1:

DISTRICT FUNDS: A budget meeting shall be held as soon as practical after the District Commander assumes office to establish an annual budget for the ensuing year. The Budget Committee shall be composed of all District officers elected and appointed and Post Commanders. The proposed budget will be presented at the first District meeting in July for approval of the floor. District funds expended other than that authorized in the budget will be expended upon a majority of the delegates present *and voting* at a regular meeting.


Section 2:

AMENDING BYLAWS: These Bylaws may be amended only by a two-thirds (2/3) vote of the delegates present *and voting* at the District Convention. No amendment will be considered unless a copy of same has been forwarded to all Posts in the District at least thirty (30) days prior to the annual District Convention. A copy of any and all amendments adopted by the District Convention shall be forwarded through channels and reviewed by the Commander-in-Chief prior to becoming effective.

Section 3:

Wherever these Bylaws or subsequent amendments may be found to be in conflict with the present or any future Department or National Bylaws, the latter shall prevail and be binding on this District as though written herein.



VFW DISTRICT 10 DEPARTMENT OF ARIZONA VFW

Article I Section 3 (New)

Add "The supreme power of this association is vested in the National Convention and this District shall be at all times governed by the Congressional Charter and By-Laws of the Veterans of Foreign Wars of the United States, the By-Laws of the Department of Arizona, orders issued by authority of the National Convention, National Council of Administration, the Commander-in-Chief, the Department Convention, Department Council of Administration and the Commander of the Department of Arizona. For the purposes of this Article and Section, Resolutions adopted by the National Convention are held to be lawful orders."

Reason: To preclude any misunderstanding on the governing authorities of the District.

Article II Section 1

Replace "Constitution" with "Congressional Charter and National"

Reason: To conform to the Congressional Charter of the Veterans of Foreign Wars of the United States.

Article III Section 2 (d)

Replace "all elected officers of the District, the District Adjutant and all past District Commanders who are members in good standing in a Post in the District." With "all Past District Commanders who are members in good standing in a Post in the District, all elective officers of the District and the Adjutant."

Reason: To preclude any misunderstanding on the governing body. To conform to Section 404 of the National By-Laws.

Article III Section 2 (e)

Replace "District Convention Meeting." With "Convention or meetings."

Reason: To conform to Section 404 of the National By-Laws.

Article IV Section 6

Replace title with "Convention and Meeting"

Replace "412, National Constitution and By-Laws, and Section 312, Manual of Procedure." With "414 of the National By-Laws and Manual of Procedure."

Reason: To conform to Section 414 of the National By-Laws and Manual of Procedure.

Article IV Section 8 b.

Add "Chief of Staff, Inspector" after "Adjutant"

Reason: To conform to Section 416 of the National By-Laws and Manual of Procedure.

Article IV Section 9

Replace "415 of the National Constitution and By-Laws" with "417 of the National By-Laws and Manual of Procedure."

Reason: To conform to Section 417 of the National By-Laws and Manual of Procedure.

Article IV Section 10

Replace with "The officers of this District shall have such duties and obligations as prescribed in the Department By-Laws and Section 418 of the National By-Laws and Manual of Procedure."

Article VI Section 1

Section 1:

OBJECTS: The objects of the District shall be as set forth in the *Congressional Charter and National By-Laws*, together with the By-Laws of the Department of Arizona and to offer all possible aid and assistance to every Post in the District.

Dues are payable within sixty (60) days after the annual District Convention. Posts in arrears will have no voice or vote at any District Convention or Meeting.

Section 5:

A registration fee shall be assessed each member attending a District Meeting or Convention. The fee will be established by a two-thirds (2/3) majority vote at a District Meeting.

Section 6:

CONVENTION AND MEETING: Solicitation of funds will be provided as to Section 414 of the *National By-Laws and Manual of Procedure*. No Post will solicit funds at any District Convention, Meeting, or Special Meeting, excluding host Posts normal functions, without the approval of the District Commander.

Section 7:

ELIGIBILITY TO OFFICE: Any member in good standing in a Post in the District shall be eligible to any office in the district; provided, no member shall hold two (2) elective District offices at the same time, but may hold one (1) elective and one (1) or more appointive offices. District officers, elective or appointive, shall be eligible to hold office in a higher or lower body. Such offices may be held concurrently. District Commanders shall be ineligible to simultaneously hold an elected Department office.

Section 8:

DISTRICT OFFICERS:

- b. The Commander shall appoint the Adjutant, *Chief of Staff*, *Inspector*, Officer of the Day, Service Officer, Guard, and such officers as he deems necessary for the pleasure of the District Commander. The Trustees shall audit the books and records of the Quartermaster and Adjutant at each regularly scheduled Meeting and report of such audits shall be furnished to the Department as required of the Posts.
- c. District Officers, elected or appointed, shall submit proof of eligibility for the files of the Adjutant prior to their installation following their election or appointment. 
